ARA Protects the Salvage Supply

National Salvage Legislation:

- **ARA** has secured the introduction of VIN Disclosure legislation in the U.S. Congress – the first step in a national effort to rid the industry of illegitimate and fraudulent use of salvage.
- **ARA** is pushing for Congress to add an export provision to the bill aimed at preventing the multiple export of motor vehicles using the same VIN number.
- **ARA** established the ARA Legislative Fund and the ARA PAC to increase the industry's influence in Washington, D.C.

ARA Secures Funding for Mercury Switch Removal

- **National Vehicle Mercury Switch Removal Program (NVMSRP)**
 - Signed August 11, 2006
 - Voluntary for Recyclers
- **IFCC Fund**
 - Guarantees minimum \$1.00/switch
 - Some states have higher incentive
 - ARA sits on IFCC board to monitor strict compliance
- **Shipping Savings**
 - NVMSRP allows recyclers to ship switches as UNIVERSAL waste
 - Thousands (\$\$\$) saved annually because switches are no longer shipped as HAZARDOUS waste
